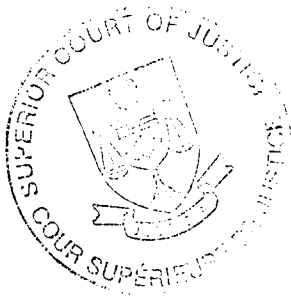
**ORDER**

**THIS ORDER** arises from a case conference held on this day.

**WHEREAS** this Court approved the settlement of this action pursuant to the Order of Justice Perell dated May 24, 2018 (the "Settlement") and whereas the claims filing deadline pursuant to the Settlement is October 24, 2018 (the "Claims Deadline").

**WHEREAS** Crawford Class Action Services ("the Administrator") was appointed as the Claims Administrator pursuant to the Order of Justice Perell dated May 24, 2018.

**AND UPON HEARING** the submissions of Class Counsel and counsel for the Defendant and being advised of their consent to this Order,



1. **THIS COURT ORDERS** that the Claims Deadline pursuant to the Settlement shall be extended to January 24, 2019, with no further extensions permitted ("Claims Deadline Extension").

2. **THIS COURT ORDERS** that notice of the Claims Deadline Extension shall be disseminated, within three (3) days of this Order, as follows:


- (a) by Class Counsel by email, to all the Provincial and Territorial Public Guardian and Trustee offices by email;
- (b) by the Administrator to any person whose contact information has been provided to, or is otherwise known to, the Administrator and/or Class Counsel or who have contacted the Administrator and/or Class Counsel;
- (c) by the Administrator and Class Counsel posting notice on their websites, and as an automated response to any person sending an email to SchoolAbuse@kmlaw.ca or to the Administrator's email for this action;
- (d) by the Administrator by email (or by regular mail if no email address is provided) to the persons and/or entities on the list of community agencies funded by the defendant to provide services to members of the Student Class, previously provided by the defendant; and
- (e) by the Administrator by email to the following organizations:
  - (i) Canadian Hearing Society;
  - (ii) the Canadian Association of the Deaf;
  - (iii) the Ontario Association of the Deaf;
  - (iv) the Toronto Association for the Deaf;
  - (v) the Western Institute for the Deaf and Hard of Hearing;
  - (vi) Deaf BC;

- (vii) Greater Vancouver Association of the Deaf;
- (viii) Society of Deaf and Hard of Hearing Nova Scotians;
- (ix) Saskatchewan Deaf and Hard of Hearing Services;
- (x) Alberta Association of the Deaf;
- (xi) Calgary Association of the Deaf;
- (xii) Deaf Centre Manitoba Inc.;
- (xiii) Edmonton Association of the Deaf;
- (xiv) Saint John Deaf and Hard of Hearing services Inc.; and,
- (xv) Newfoundland & Labrador Association of the Deaf;

and request that they post the notice on their websites, distribute it on any listservs they maintain, and otherwise distribute it in a manner that will likely come to the attention of class members, such as via a text message blast.

3. **THIS COURT ORDERS** that the costs of distributing the notice described in paragraph 2 above shall be paid from the Settlement Fund, as defined in the Settlement Agreement.

4. **THIS COURT ORDERS** that the content of notice of the Claims Deadline Extension shall be substantially in the form attached as Schedule "A" and modified as necessary to facilitate the notice described in paragraph 2 above.
